Copyright refers to the legal right of the owner of intellectual property. In simpler terms, copyright is the right to copy. This means that the original creators of products and anyone they give authorization to are the only ones with the exclusive right to reproduce the work.



Copyright law gives creators of original material the exclusive right to further use and duplicate that material for a given amount of time. Once a copyright expires, the copyrighted item becomes public domain.

# HOW COPYWRITING WORKS

When someone creates a product that is viewed as original and that required significant mental activity to create, this product becomes an intellectual property that must be protected from unauthorized duplication. Examples of unique creations include:

- Novels
- Art
- Poetry
- Musical lyrics and compositions
- Computer software
- Graphic designs,
- Film
- Original architectural designs
- Website content

## Who is eligible for the Copyright Registration in India?

An author, original owner or authorised agent everyone is eligible for the Copyright Registration in India.

# Documents Required for Copyright Registration in India

Here is the list of some common documents required for Copyright Registration in India:

- 2 Copies of the Work
- Demand Draft (in case of Offline Registration)
- NOC from Author/ Various Copyright holders/ Publisher
- Power of Attorney (if the application is filed by any attorney)
- Identity Proof of the applicant (ex- Aadhar card, PAN card, etc)

*Fees-* The cost of Copyright Registration in India varies from ₹500 to ₹40,000 depending on the nature of the work and creation.

*Note: The documents can be different on the basis of the work material or original creation.*
